

PVCA Homecoming, Parade, and Procession Guidelines

All Events

- All drivers and passengers must sign the NCCC approved waiver. **No one will be allowed to drive or ride without a signed waiver.**
 - Passengers aged 18 or older must sign and provide the adult waiver at the event.
 - Passengers under age 18 may have their parent or guardian sign the minor waiver in advance.
- Passengers shall not open car doors or enter the car without knowledge and supervision of the driver.
- PVCA would appreciate a brief acknowledgement in your announcement. Example:
 - We (name of school or city) would like to thank Pomona Valley Corvettes for escorting our homecoming court/parade dignitaries today
- PVCA Members may take pictures and/or videos during the event and publish them to the PVCA website and/or social media;
 - If your school or any of your participants do not want pictures/videos taken and published please let us know.

For High School Homecomings, Winter events, etc. (closed course only, less than 10 MPH)

- PVCA asks that all requests be submitted at least 3-weeks before the event. It takes time to organize and get the cars and our members committed. Late requests may be accommodated if cars/drivers are available.
- Capacity for a given date is limited by the number of cars and drivers we have available. Preference will be given to schools we supported the prior year, then on a first-come, first-served basis.
- No signage allowed for stadium events since riders are announced. Signage is allowed for homecoming parades per the parade rules below.
- Pricing is \$35 per car, single trip around the track. If a car needs to make multiple trips, each trip is \$35
- Passenger limit is 2 per car, per trip. One passenger on the roof hoop or deck and one in the passenger seat.
- Passengers who are also athletes coming off the field for halftime MAY be allowed depending on details. Must have no dirt or mud, and any equipment such as cleats that could damage the car must be removed. Requires prior approval. **Please discuss with our coordinator if you have any of these.**

For Public City, School, or Community Sponsored Parades (closed course only, less than 10 MPH)

- Same lead time, passenger limits, requirements, and rules apply.
- Signage for passenger name etc.
 - Minimum- Maximum size: 20" to 30" wide and 15" to 20" high
 - Corvette bodies are plastic, magnetic signs will **NOT** work.
 - Paper and lightweight card-stock signs can be taped on with tape provided by the driver.
 - Avoid chipboard, posterboard, foamboard, glitter, appliqué, ribbons, and other materials that weigh down the sign or could scratch the car.
 - Low-tac adhesive backed vinyl stickers/signs may work. **Please contact our coordinator for review and prior approval**
 - Contact our coordinator if you have any signage questions.
- Unless the parade route ends where it began, PVCA will not typically return the passenger/s to the parade start. Please be sure to provide your own transportation. We may be able to provide return transportation **ONLY** if arranged in advance. Only one passenger is allowed per car for any driving on an open public road.
- Parade pricing will be determined on a case-by-case basis

For Private and Commercial Events and Processions (closed course or open public road)

- These types of events will require PVCA Board approval, and we ask for as much advance notice as possible.
- Same passenger limits, requirements, and rules apply for closed course events.
- Only one passenger is allowed per car for any event driving on an open public road.
- Pricing, determined on a case-by-case basis
